<u>ARS Office/Lab and Location</u>: A research opportunity is currently available with the U.S. Department of Agriculture (USDA), Agricultural Research Service (ARS), Sustainable Agricultural Systems Laboratory (SASL) located in Beltsville, Maryland.

The Agricultural Research Service (ARS) is the U.S. Department of Agriculture's chief scientific inhouse research agency with a mission to find solutions to agricultural problems that affect Americans every day from field to table. ARS will deliver cutting-edge, scientific tools and innovative solutions for American farmers, producers, industry, and communities to support the nourishment and well-being of all people; sustain our nation's agroecosystems and natural resources; and ensure the economic competitiveness and excellence of our agriculture. The vision the agency is to provide global leadership in agricultural discoveries through scientific excellence.

**Research Project**: The selected participant will have the opportunity to refine their skills with hands on research, being involved in executing experiments under the Organic Research and Education initiative Weed and Insect Management in Organic Rotational No-Till Agriculture. The mission of our group is to address agronomic challenges (e.g., crop, pest and soils) while reducing tillage in organic field crop production.

This opportunity requires some physical exertion, such as regular and recurring walking and or bending. In many situations, the duration of the activity (such as most of the day) contributes to the arduous nature of the research. In other situations; there may be special requirements for agility or dexterity such as exceptional hand/eye coordination. The research involves regular and recurring moderate risks or discomforts, which require special safety precautions, e.g. being outside in the sun and exposure to outside temperatures. The participant is required to use protective clothing, such as boots, goggles and gloves when conducting research in situations that present a safety hazard.

Learning Objectives: Under the guidance of a mentor, the participant will collaborate with

scientists in a variety of activities including: field, greenhouse, and lab experiments. The participant will learn how cover crops are being used to benefit actual farmers and the environment through interactions with stakeholders throughout the Del- Marva region. This learning experience will follow the life cycle of cover and cash crops from planting to harvest.

Professional development opportunities are available for the participant to meet with farmers, attend scientific meetings, learn how to write and present research posters and/or talks to peers.

<u>Anticipated Appointment Start Date</u>: Summer 2021. Start date is flexible and will depend on a variety of factors.

<u>Appointment Length</u>: The appointment will initially be for one year, but may be extended upon recommendation of ARS and is contingent on the availability of funds.

Level of Participation: The appointment is full-time.

<u>Participant Stipend</u>: The participant will receive an annual stipend commensurate with educational level and experience.

<u>Citizenship Requirements</u>: This opportunity is available to U.S. citizens, Lawful Permanent Residents (LPR), and foreign nationals.
