Research Project: Research activities for the proposed project will primarily focus on genetic characterization and management of hemp and selected vegetable genetic resources, including tomato, onion, brassica, celery, asparagus, tomatillo, ground cherry, winter squash, radish, and buckwheat. The selected participant will participate in specific research projects and apply contemporary multidisciplinary science and technology skills to address diverse questions within crop genetic resource conservation. Research topics may include but are not limited to: phenomic and genomic characterization, curation and documentation, and propagation and distribution of genetic resources to diverse stakeholders. The knowledge, experience, methods, and technologies may come from plant genetics, molecular biology and genomics, breeding, computational biology, population and quantitative
