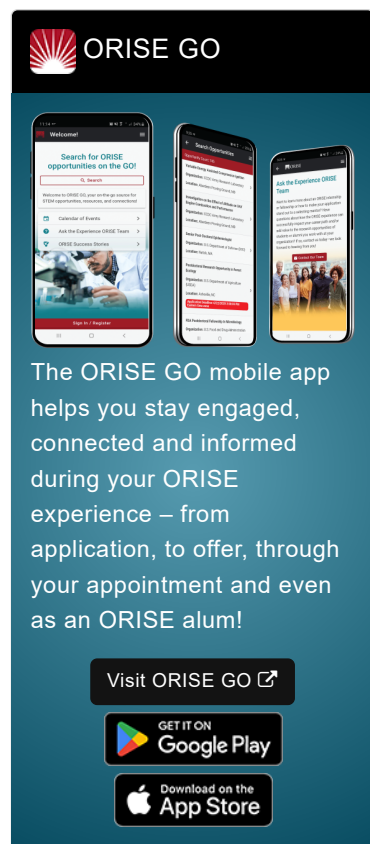

The Centers for Disease Control and Prevention (CDC) is one of the major operation components of the Department of Health and Human Services. CDC works to protect America from health, safety and security threats, both foreign and in the U.S. Whether diseases start at home or abroad, are chronic or acute, curable or preventable, human error or deliberate attack, CDC fights disease and supports communities and citizens to do the same.

Research Project: Diversity, Equity, Belonging, Inclusion, and Accessibility (DEBIA) is an agency and center priority, and NCIPC leadership has deemed DEBIA among the core values for the center. The fellow will have access to Center leadership and conduct fellowship activities by building and implementing a center-level framework and overarching strategy to advance DEBIA across the center in all organizational practices and operations.

Under the guidance of mentors, the participant will be trained to:

- Conduct data calls and collaborate with division and office-level points of contact to document ongoing and planned activities related to DEBIA.
- Collaborate with a subject matter expert(s) in DEBIA to ensure that center activities are based on the best available evidence
- Participate in the coordination of activities related to a Strategy Sub-Committee, dedicated to drafting NCIPC's DEBIA strategic plan.
- Participate in the Committee on Diversity workgroup
- Review assessments from the Center to help guide DEBIA-related activities, policies, and processes in all aspects of our work and

Participant Stipend: The participant will receive a monthly stipend commensurate with educational level and experience. **A travel/training allowance may also be provided based on the discretion of the mentor and the CDC program.**

Citizenship Requirements: This opportunity is available to U.S. citizens only.

ORISE Information: This program, administered by ORAU through its contract with the U.S. Department of Energy (DOE) to manage the Oak Ridge Institute for Science and Education (ORISE), was established through an interagency agreement between DOE and CDC. Participants do not become employees of CDC, DOE or the program administrator, and there are no employment-related benefits. Proof of health insurance is required for participation in this program. Health insurance can be obtained through ORISE.

The successful applicant(s) will be required to comply with Environmental, Safety and Health (ES&H) requirements of the hosting facility, including but not limited to, COVID-19 requirements (e.g. facial covering, physical distancing, testing, vaccination).
