

**EPA Office/Lab and Location:** A research opportunity is available at the Environmental Protection Agency (EPA), Office of Research and Development (ORD), Center for Public Health Environmental Assessment (CPHEA), Health & Environmental Effects Assessment Division (HEEAD) located in Washington, D.C.

**Research Project:** EPA ORD provides scientific leadership for evaluating human health and ecological risks associated with exposure to physical, chemical, and biological stressors, including environmental pollutants and climate change. CPHEA is responsible for environmental assessments that inform regulatory offices of the EPA, regions, states, communities, and authorized tribes. This involves the use of both environmental and social sciences to clearly articulate the attributes of ecosystems that are valued by stakeholders, analyze, and synthesize information from disparate sources, and communicate the uncertainties inherent in the conclusions. Assessments must also consider the context of decision making, and as such use translational research approaches that involve stakeholders in problem formulation and development of assessment goals and strategies that result in products designed to be highly usable and actionable. The focus of this research opportunity is at the intersection of social science, environmental assessment, and climate change vulnerability and adaptation.


The research participant will have the opportunity to engage in the development of frameworks, tools, assessment methods, and processes to

help build regional and community capacity to achieve sustainable natural resources and address cumulative impacts of stressors to underserved communities. This may involve interacting with environmental scientists on stakeholder co-production through human-centered design (HCD) of an interactive online “organon” (thought instrument or logic system) for building capacity of regional and local stakeholders to organize, understand, and integrate climate change vulnerability and resilience-based knowledge into management decisions and project designs for sustainable natural resources. The organon will be piloted through regional case studies to test its utility for supporting orientation and education, program evaluation, and detailed project planning centered on resilience to changing environmental conditions.

This research opportunity may also involve assisting in the development and evaluation of citizen science projects, focusing on the ways they may strengthen community capacity for environmental problem solving. In these activities, the research participant will have the opportunity to engage in identification of social elements of social-environmental systems and assist with research designs to incorporate these elements into translational science strategies and community-driven solutions.

**Learning Objectives:** The research participant will have the opportunity to learn and practice approaches for designing products, engaging with project partners, and developing outreach materials. The participant will gain an understanding of how scientific evidence is used to inform EPA decision-making processes. The participant will also have the opportunity to collaborate with scientific staff in CPHEA, EPA Regions, states, and communities.

Under the guidance of a mentor, specific research training activities may include:

- Designing and implementing HCD workshops with regional, state, community, and local partners to explore user needs and gather feedback on tools
- Assessing climate change impacts, vulnerability, resilience, and adaptation in human and natural systems
- Assessing regional, state, and local needs and priorities for environmental and socio-economic indicators, equitable climate resilience, economic development, and regional planning
- Conducting prototype development and testing through co-production with project partners
- Conducting case studies of equitable resilience planning in local communities, using qualitative data gathering and analysis methods
- Researching ways that citizen science projects can be designed to enhance community capacity for addressing environmental problems
- Designing and executing regional case studies in collaboration with interdisciplinary teams of natural resource managers and other experts
- Contributing to sections of highly influential science assessments and literature reviews
- Preparing peer-reviewed manuscripts, reports, presentations, and
