
CDC Office and Location: A fellowship opportunity is currently available with the Million Hearts® team which sits in the Office of the Director, Division for Heart Disease and Stroke Prevention (DHDSP), National Center for Chronic Disease Prevention and Health Promotion (NCCDPHP), at the Centers for Disease Control and Prevention (CDC) in Atlanta, Georgia.

The Million Hearts® core team supports the Million Hearts® initiative. Million Hearts® is a national initiative co-lead by CDC and Centers for Medicare and Medicaid Services (CMS) to prevent one million cardiovascular (CV) events in five years. Research Project: Under the guidance of a mentor, the selected participant will have the opportunity to gain experience being part of a small and dynamic team that is supporting a national public health initiative to prevent heart attacks and strokes.
