The fellow's training opportunities will include surface sampling, DNA extraction, PCR, library preparation and next generation sequencing.

Learning Objectives: The fellow will gain experience collaborating with other teams and branches within DHQP and in communicating findings with CDC colleagues and public health partners.

<u>**Participant Stipend:**</u> The participant will receive a monthly stipend commensurate with educational level and experience.
