Description *Applications are reviewed on a rolling-basis.

ARS Office/Laboratory and Location: A research opportunity is currently available with the U.S. Department of Agriculture (USDA), Agricultural Research Service (ARS), within the Cotton Structure and Quality Research Unit at the Southern Regional Research Center located in New Orleans, Louisiana.

Research Project: Research projects will be conducted to develop improved natural fiber (cotton, hemp, etc.) quality measurements. Research will involve improving and developing methods to measure fiber length, strength, color, and fineness, including the distribution of the fiber properties. Phenotyping of natural fibers including cotton, hemp, and flax needs to be refined to enable industry development and provide opportunities for breeders to improve germplasm.

Learning Objectives: The training opportunity will provide learning opportunities in standard and novel fiber measurement techniques and the development process for internationally accepted standards.

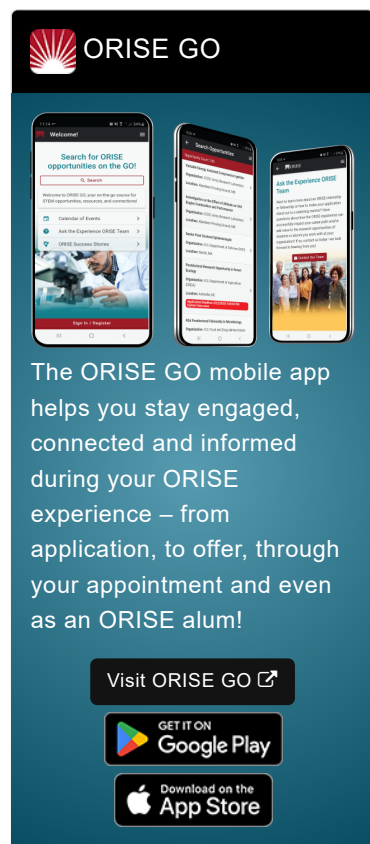
