**<u>CDC Office and Location</u>**: A fellowship opportunity is available with the Office of Health Equity within the National Center for HIV, Viral Hepatitis, STD, and TB Prevention (NCHHSTP) at the Centers for Disease Control and Prevention (CDC) located in Atlanta, Georgia.

The Centers for Disease Control and Prevention (CDC) is one of the major operation components of the Department of Health and Human Services. CDC works to protect America from health, safety and security threats, both foreign and in the U.S. Whether diseases start at home or abroad, are chronic or acute, curable or preventable, human error or deliberate attack, CDC fights disease and supports communities and citizens to do the same.

**Research Project:** The postdoctoral fellow will receive training from NCHHSTP Office of Health Equity mentors in developing and implementing research projects that inform the development of effective strategies and interventions to reduce disparities in HIV, other STDs, TB and viral hepatitis. Effective strategies will support the guiding principal of high impact prevention, a public health approach to disease prevention in which proven, cost-effective and scalable interventions are implemented for preventing the greatest amount of infections or for reducing disparities, given available resources. Mentors and fellows will collaborate to develop a list of diverse research activities that they will complete together over the two year (subject to funding) training period. These activities will be based on the fellow's area(s) of interest, training, and expertise and the mission of the NCHHSTP Office of Health Equity.
