**FDA Office and Location:** A research opportunity is available within the Food and Drug Administration (FDA) in The Center for Food Safety and Applied Nutrition (CFSAN), Office of Regulatory Science (ORS) located in College Park, Maryland.

The Center for Food Safety and Applied Nutrition, known as CFSAN, provides services to consumers, domestic and foreign industry and other outside groups regarding field programs; agency administrative tasks; scientific analysis and support; and policy, planning and handling of critical issues related to food, dietary supplements, and cosmetics.

**Research Project:** The goals of this project are to improve the methods for detection of Salmonella from complex environmental samples including soils, sediments, water, and air. Currently no validated, standardized methods exist for detection of Salmonella from these matrices. Having standardized, validated methods is critically important for FDA/CFSAN investigations of produce-borne outbreaks. Initially the project will focus on modification to FDA-BAM culture methods that may increase the recovery of Salmonella. To help in understanding culture dynamics metagenomic sequencing and analysis will be applied.

**Learning Objectives:** The participant will receive hands-on training from the mentor in the following tasks during the specified period:

- CFSAN and Division of Microbiology (DM) biosafety procedures for handling pathogenic bacterial cultures.
- DM laboratory methods, including generation and analysis of DNA sequence data from foodborne pathogens using

**Appointment Length:** The appointment will initially be for two and a half months, but may be renewed upon recommendation of FDA and is contingent on the availability of funds.

Level of Participation: The appointment is full time.

**Citizenship Requirements:** This opportunity is available to U.S. citizens only.

This program, administered by ORAU through its contract with the U.S. Department of Energy to manage the Oak Ridge Institute for Science and Education, was established through an interagency agreement between DOE and FDA. The participant will receive a monthly stipend commensurate with educational level and experience. Proof of health insurance is required for participation in this program. Participants do not become employees of FDA, DOE or the program administrator, and there are no employment-related benefits.

Completion of a successful background investigation by the Office of Personnel Management is required for an applicant to be on-boarded at FDA. OPM can complete a background investigation only for individuals, including non-US Citizens, who have resided in the US for a total of three of the past five years.

## **FDA Ethics Requirements**

If an ORISE Fellow, to include their spouse and minor children, reports what is identified as a Significantly Regulated Organization (SRO) or prohibited investment fund financial interest in any amount, or a relationship with an SRO, except for spousal employment with an SRO, and the individual will not voluntarily divest the financial interest or terminate the relationship, then the individual is not placed at FDA.
