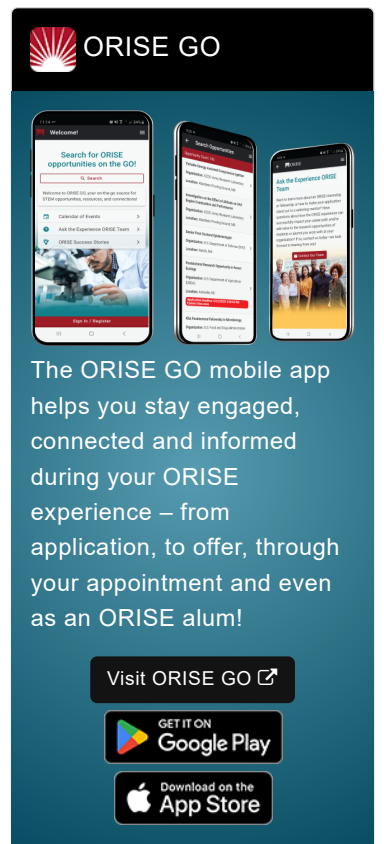

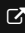

- Design, conduct, and interpret an analysis on public health data.
- Conduct oral presentations at an internal NCCDPHP engagements.
- Multidisciplinary collaboration, coordination, action planning, and communication as part of NCCDPHP Health Equity Council, DEIAB Council, and other Health Equity/SDOH/DEIAB related workgroups.
- Building organizational capacity to advance health equity and enhance DEIAB initiatives through the implementation of needs and trainings assessments other related assets in NCCDPHP workforce and workplace.
- Learn NCCDPHP center priorities and areas for innovation by observing NCCDPHP HE strategic planning discussions and other related engagements.

**Level of Participation:** The appointment is full-time.

**Participant Stipend:** The participant will receive a monthly stipend commensurate with educational level and experience.

**Citizenship Requirements:** This opportunity is available to U.S. citizens and Lawful Permanent Residents (LPR).

**ORISE Information:** This program, administered by ORAU through its contract with the U.S. Department of Energy (DOE) to manage the Oak Ridge Institute for Science and Education (ORISE), was established through an interagency agreement between DOE and CDC. Participants do not become employees of CDC, DOE or the program administrator, and there are no employment-related benefits. Proof of health insurance is required for participation in this program. Health insurance can be obtained through ORISE.

**Qualifications** The qualified candidate should have received a master's or doctoral degree in one of the relevant fields, or be currently pursuing a doctoral degree at an accredited U.S. college or university in public health, behavioral or social sciences fields (e.g. psychology, sociology, anthropology), or other listed related disciplines. Degree must have been received within five years of the appointment start date.

**Preferred skills:**

- Course work and/or experience in public health, health or social psychology, behavioral health.
- Statistics and data analysis, including experience using statistical computing software such as Excel, SAS and/or SPSS
- Knowledge of public health and population level strategies for chronic disease prevention and management
- Knowledge regarding principles and/or strategies to advance HE/SDOH and DEIAB
- Experience in communicating scientific and/or programmatic knowledge and ideas to multidisciplinary teams and diverse groups of people, including through use of visual aids (e.g. Microsoft Power Point).
- Experience in scientific writing, including the development of articles for peer reviewed journals
- Strong written and verbal communication skills
- Ability to engage effectively and collaboratively within and across teams
- Professionalism and customer service skills
