CDC Office and Location: A research opportunity is available in the Centers for Disease Control and Prevention (CDC).

The Centers for Disease Control and Prevention (CDC) is one of the major operation components of the Department of Health and Human Services. CDC works to protect America from health, safety and security threats, both foreign and in the U.S. Whether diseases start at home or abroad, are chronic or acute, curable or preventable, human error or deliberate attack, CDC fights disease and supports communities and citizens to do the same.

Selected candidates must either live within a 50 mile radius of an approved CDC duty location or be able to relocate before the start of the appointment.

Research Project: Vaccines are a core part of infectious disease prevention and control. Optimal use of a vaccine depends on its efficacy in preventing infection, transmission, symptoms, hospitalization, or death. In this project, the fellow will train to develop innovative disease modeling frameworks to simulate the effects of waning vaccine protection, including model fitting techniques to analyze waning patterns using epidemiological, serological, and other public health data.

Learning Objectives: The fellow will train in the Medical Countermeasures & Variants team at the CDC's Center for Forecasting and Outbreak Analytics. They will learn about infectious disease modeling and vaccinology. They will gain experience in researching collaboratively with modelers and programmers, train in building high-quality code and using GitHub to collaborate on a shared codebase. The fellow will learn other quantitative epidemiology and software development activities tailored to their specific skill set.
