

APHIS Office/Lab and Location: A research opportunity is currently available with the U.S. Department of Agriculture (USDA), Animal Plant Health Inspection Service (APHIS), National Veterinary Services Laboratory (NVSL), located in Manhattan Kansas, Orient Point New York, or remote.

The Animal and Plant Health Inspection Service (APHIS) is a multi-faceted Agency with a broad mission area that includes protecting and promoting U.S. agricultural health, regulating genetically engineered organisms, administering the Animal Welfare Act and carrying out wildlife damage management activities. These efforts support the overall mission of USDA, which is to protect and promote food, agriculture, natural resources and related issues. APHIS' mission also includes addressing issues such as wildlife damage and disease management; regulation of genetically engineered crops and animal welfare; and protection of public health and safety as well as natural resources that are vulnerable to invasive pests and pathogens.

The USDA APHIS Foreign Animal Disease Diagnostic Laboratory (FADDL) of the National Veterinary Services Laboratories (NVSL) is stationed at the Plum Island Animal Disease Center (PIADC) in Orient Point, New York; the National Bio and Agro Defense Facility (NBAF) in Manhattan, Kansas; and with the Puerto Rico Department of Agriculture (PRDA) in Dorado, Puerto Rico. FADDL's mission is focused on providing diagnostic testing for high-consequence diseases of livestock, including African swine fever, Classical

swine fever, and foot-and-mouth disease.

Research Project: The Foreign Animal Disease Diagnostic Laboratory (FADDL) is undergoing a time of transition from the Plum Island Animal Disease Center (PIADC) to the National Bio and Agro Defense Facility (NBAF), as well as building programs with the Puerto Rico Department of Agriculture. Given the opportunities to build programs and develop a highly-skilled workforce, training is key. Under the guidance of a mentor, the purpose of this project is to develop innovative, cutting-edge, and effective training for FADDL's scientific program.

Learning Objectives: Under the guidance of a mentor, the fellow will be involved in the following learning activities:

- Meet with FADDL scientific staff to identify training needs and assist with developing a strategy for content creation
- Investigate training development computer programs that can be used to create training materials (e.g. interactive animations, reference documents, etc.)
- Assist with developing a strategy to implement and track training effectiveness in scientific staff to meet program needs
- Analyze training performance and metrics to develop a science-based and effective training program
- Research of laboratory assays and standard operating procedures (SOPs) to develop content creation
- Develop content in the forms of videos, online courses, webinars, and quizzes, etc.

Participant Stipend: The participant will receive a monthly stipend commensurate with educational level and experience.
