CDC Office and Location: A fellowship opportunity is available with the <u>Division of High-Consequence Pathogens and Pathology (DHCPP) in</u> the <u>National Center for Emerging and Zoonotic Infectious Diseases (NCEZID)</u> at the Centers for Disease Control and Prevention (CDC) in Atlanta, Georgia. This opportunity is full-time and requires reporting to the location in-person 2-3 days per week in Atlanta, Georgia.

The <u>Centers for Disease Control and Prevention (CDC)</u> is one of the major operations components of the Department of Health and Human Services.
