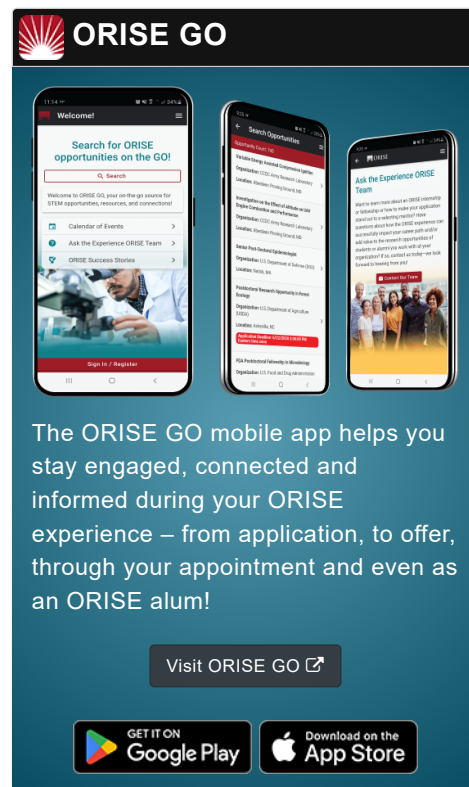

Description	<p>The Minority Serving Institutions Partnership Program (MSIPP) Internships is a new program to promote the education and development of the next generation workforce in critical science, engineering, technology, and math (STEM) related disciplines that complement current and future missions of DOE national laboratories. The MSIPP Internship program is designed to provide an enhanced training environment for next generation scientists and engineers by exposing them to research challenges unique to our industry.</p> <p>MSIPP Interns will be given the opportunity to complete Summer Internships aligned with ongoing U.S. Department of Energy Office of Environmental Management (DOE-EM) research under the direction of a host national laboratory. The internship will be performed at the host national laboratory, utilizing their facilities and equipment under the guidance of a research staff member.</p> <p>Minority Serving Institutions are institutions of higher education enrolling populations with significant percentages of undergraduate minority students.</p> <p>Project: This project will focus on the remediation of contaminated soil and groundwater. Projects will be focused on technology development on remedial amendment delivery to the subsurface and establish amendment release sources in the target zones. The student will be responsible for laboratory experimental studies.</p> <p>Location: This internship will be located at Pacific Northwest National Lab.</p>

- Working toward a science, technology, engineering, or mathematics (STEM) degree,
- Have an undergraduate or graduate cumulative minimum Grade Point Average (GPA) of 3.0 on a 4.0 scale, and
- Pass a drug test upon selection to participate in the MSIPP*The process and timing for drug testing varies from lab to lab.Use of Marijuana/Cannabis or its derivatives if prescribed is legal in some states.However, having these drugs in your system is NOT legal at United States Federal Contractor sites and National Laboratories.
