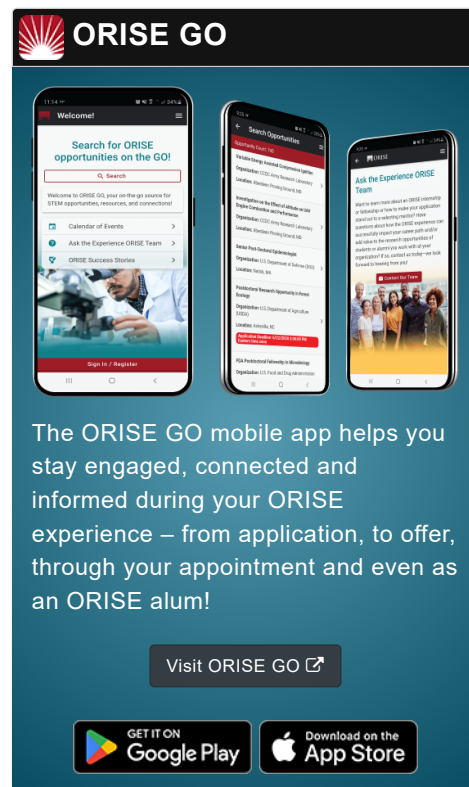

Description	<p>The Minority Serving Institutions Partnership Program (MSIPP) Internships is a new program to promote the education and development of the next generation workforce in critical science, engineering, technology, and math (STEM) related disciplines that complement current and future missions of DOE national laboratories. The MSIPP Internship program is designed to provide an enhanced training environment for next generation scientists and engineers by exposing them to research challenges unique to our industry.</p> <p>MSIPP Interns will be given the opportunity to complete Summer Internships aligned with ongoing U.S. Department of Energy Office of Environmental Management (DOE-EM) research under the direction of a host national laboratory. The internship will be performed at the host national laboratory, utilizing their facilities and equipment under the guidance of a research staff member.</p> <p>Minority Serving Institutions are institutions of higher education enrolling populations with significant percentages of undergraduate minority students.</p> <p>Project: This project involves conducting cybersecurity needs and vulnerability assessments for environmental systems (ex. waste treatment, recycling facility, solar electric grid, etc.). Collaborating with other interns to gather requirements, complete assessment tasks, and generate a final report with recommendations. Contributing to proposal writing to gain funding for cybersecurity improvements, following assessments.</p> <p>Location: This internship will be located at Los Alamos National Laboratory.</p>

Salary: Selected candidates will be compensated by either a stipend or salary, and may include one round trip domestic travel to and from the host laboratory. Stipends and salaries will be commensurate with cost of living at the location of the host laboratory. Housing information will be provided to interns prior to arrival at the host laboratory, and will vary from lab to lab.

Hours: Full-Time or Part-Time

Application Deadline: January 12, 2018

Expected Start Date: The program is 10 weeks in duration, starting May 21, 2018. Start date is flexible based on laboratory and candidate availability.

Qualifications Eligible applicants must:

- Be a citizen of the United States,
- Be at least 18 years of age,
- Currently enrolled as a full-time undergraduate or graduate student at an accredited Minority Serving Institution, <http://orise.ornl.gov/msipp/documents/approved-msi-school-list.pdf>,
- Working toward a science, technology, engineering, or mathematics (STEM) degree,
- Have an undergraduate or graduate cumulative minimum Grade Point Average (GPA) of 3.0 on a 4.0 scale, and
- Pass a drug test upon selection to participate in the MSIPP

*The process and timing for drug testing varies from lab to lab. Use of Marijuana/Cannabis or its derivatives if prescribed is legal in some states. However, having these drugs in your system is NOT legal at United States Federal Contractor sites and National Laboratories.

Required Knowledge, Skills, Work Experience, and Education

Successful candidates will:

- Be a current undergraduate or graduate students pursuing a degree in computer science, computer/electrical engineering, mathematics, or related field.
- Background/field of study in one or more of the following: computer engineering, electrical engineering, computer security, cyber-physical, internet of things, control systems security, embedded programming, firmware, computer
