Description A summer fellowship opportunity is available to support the Division of Applied Research and Technology (DART) within the National Institute for Occupational Safety and Health (NIOSH) at the Centers for Disease Control and Prevention (CDC) in Cincinnati, Ohio.

The participant will be offered the opportunity to train in the Engineering and Physical Hazards Branch of the CDC/NIOSH Division of Applied Research and Technology. The participant will gain experience in both office and laboratory environments by conducting research, making sound measurements, calculating efficacy of engineering noise controls, calibrating instruments and collecting and summarizing sound level data. All participation and training will occur under the tutelage and direction of an assigned Advisor/Mentor.

The participant will receive a monthly stipend commensurate with educational level and experience. Proof of health insurance is required for participation in this program. The appointment is full-time at CDC in the Cincinnati, Ohio area. Participants do not become employees of CDC, DOE or the program administrator, and there are no employment-related benefits.
