A research opportunity is currently available with the Travelers' Health Branch (THB), Division of Global Migration and Quarantine (DGMQ), within the National Center for Emerging and Zoonotic Infectious Diseases (NCEZID) at the Centers for Disease Control and Prevention (CDC) located in Atlanta, Georgia.


The Travelers' Health Branch works to keep US residents safe and healthy while traveling and living overseas. The branch is responsible for evaluating risk, monitoring disease outcomes, developing interventions, and reducing the risk for travel-related illness in US residents.

The selected participant will be placed in the Travelers' Health Branch (THB) and will be involved with several health communication and education projects for travelers and travel medicine experts. In this project, the participant will train with health communication and education specialists, medical officers and subject matter experts in other areas of CDC as well as public health professionals from outside the agency. Projects will include, but are not limited to, contributing to the development of Travel Health Notices for CDC's Travelers' Health website and collaborating with the branch's medical editors to participate in the development of the popular CDC publication "Health Information for International Travel" (a.k.a The Yellow Book).

### Anticipated Appointment Start Date: December 2019

This program, administered by ORAU through its contract with the U.S. Department of Energy to manage the Oak Ridge Institute for Science and Education, was established through an interagency agreement between DOE and CDC. The initial appointment can be up to one year, but may be renewed upon recommendation of CDC contingent on the availability of funds. The participant will receive a monthly stipend commensurate with educational level and experience. Proof of health insurance is required for participation in this program.
