**Description** *\*Applications will be reviewed on a rolling-basis.*

A research opportunity is currently available with the Monitoring, Assessment and Evaluation unit of the Evaluation, Policy, Innovations and Curriculum team in the Workforce Institute and Development Branch/Division of Global Health Protection, within the Center for Global Health (CGH) at the Centers for Disease Control and Prevention (CDC) located in Atlanta, Georgia.

Under the guidance of a mentor, the participant will learn about CDC's global health capacity building programs by collecting and analyzing information about the impact that implementation of Field and Epidemiology Training Programs (FETP) has on the public health work of graduates specifically and on the public health system in general. The participant will focus special attention to FETP implementation in the Francophone countries of West Africa. The participant can expect to gain skills in (1) assessing the validity of the information collected; (2) analyzing the information and communicating findings to technical and lay audiences through written and oral products by participating in team, branch and division-level planning meetings.

The participant will be involved in branch, team and groups for monitoring and evaluation of FETP, and this will include the following activities:

- Updating of FETP quarterly data requests and annual reports
- Data entry as requested by the Monitoring, Assessment and Evaluation unit
- Updating of the "historic database" that feeds the FETP Info tool

This program, administered by ORAU through its contract with the U.S. Department of Energy to manage the Oak Ridge Institute for Science and Education, was established through an interagency agreement between DOE and CDC. The initial appointment can be up to one year, but may be renewed upon recommendation of CDC contingent on the availability of funds. The participant will receive a monthly stipend commensurate with educational level and experience. Proof of health insurance is required for participation in this program. The appointment is full-time at CDC in the Atlanta, Georgia, area. Participants do not become employees of CDC, DOE or the program administrator, and there are no employment-related benefits.

**Qualifications** The qualified candidate should have received a bachelor's degree in one of the relevant fields, or be currently pursuing the degree and will reach completion by the end of August 2020. Degree must have been received within five years of the appointment start date.
