nurses. The campus includes the VA Fairfield Outpatient Clinic, a Clinical Investigation Facility, a community-supported Fisher House, the largest Hyperbaric Medicine chamber on the west coast and the Armed Services Whole Blood Processing Laboratory.

Under the guidance of a mentor, the participant selected for this research project will:

- Learn theoretical and practical skills to successfully develop an idea, assess study feasibility, draft protocol and informed consent documents, execute successful studies, and write abstracts, posters, and manuscripts.
- Develop technical skills to perform statistical-analysis and conduct meta-analyses.

The fellow will be exposed to at least 1 clinical trial and 1 meta-analysis ideally leading towards successful publications augmenting their training and career aspirations.

**Appointment Length**

This appointment is a twelve month research appointment, with the possibility to be renewed for additional research periods. Appointments may be extended depending on funding availability, project assignment, program rules, and availability of the participant.
