Established under the Air Force Research Laboratory, the 711 HPW is comprised of the Airman Systems Directorate (RH) and the United States Air Force School of Aerospace Medicine (USAFSAM). The Air Force Research Laboratory (AFRL) conducts cuttingedge research and development (R&D) for the U.S. Air Force. Its products transition to systems centers and the field. It employs 10,000 people and expends nearly \$5 billion per annum.

The participant will conduct original historical research, analysis, and writing into topics that involve AFRL's science and technology (S&T) activities as well as policy and personnel issues. This may entail activity for the AFRL history office's periodic history or stand-alone scholarly research and essays. The participant will be asked, at times, to participate in collaborative activities with other historians and to function

independently, at other times, on independent projects. At all times, the level of work will approximate postdoctoral activity and require highly developed historian skills.

Appointment Length

This appointment is a twelve month research appointment, with the possibility to be renewed for additional research periods. Appointments may be extended depending on funding availability, project assignment, program rules, and availability of the participant.

Participant Benefits
